

Message on National Lok Adalat

Sikkim State Legal Services Authority is organizing the National Lok Adalat on Saturday the 13th of May, 2023 for the following types of pre-litigation and pending cases viz:

(A). Pre-litigation:

- i. Cases under Section 138, Negotiable Instrument Act; 1881;
- ii. Money Recovery;
- iii. Labour disputes.

(B). Pending in the Courts:

All type of civil and compoundable criminal cases including following:

- i. Criminal Compoundable Offences;
- ii. Cases under Section 138, Negotiable Instruments Act; 1881
- iii. Money Recovery cases;
- iv. Motor Accident Claim cases;
- v. Labour dispute cases;
- vi. Disputes related to Public Utility services such as Electricity & Water Bills cases etc. (excluding non-compoundable);
- vii. Matrimonial disputes (except divorce)
- viii. Land Acquisition cases;
- ix. Services matters including pension cases;
- x. Revenue cases, pending before High Court and district Courts;
- xi. Other civil cases (rent, easmentary rights, injunction suits, specific performance suits etc.).

Any individual or any department having such matters either pending in Courts/Tribunals/Departments or in pre-litigation stage may approach the District Lok Adalats or Taluk Lok Adalats for settlement of any matters as listed above on or before 06.05.2023 at the following addresses:
