# SENSITIZATION-CUM-TRAINING PROGRAMME ON SEXUAL HARASSMENT OF WOMEN AT WORKPLACE (PREVENTION, PROHIBITION AND REDRESSAL) ACT, 2013

In compliance with the directions of the Hon'ble High Court of Sikkim in the W.P. (PIL) No. 05/2015 (Yangchen Dahdul v. State of Sikkim & Others) and as per the Sikkim SLSA's State Plan of Action 2017-18, Sikkim SLSA in co-ordination with District Legal Services Authorities of South, West and North Districts of Sikkim organized Sensitization-cum-Training Programmes on Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 for the female employees and Members of Internal Complaints Committee constituted in the various Governmental Departments, Public Undertakings, Banks, Companies and Private Sectors in the respective districts. Training-of-Trainers programme for the Panel Advocates was also conducted in these four districts.

# INTERNATIONAL DAY AGAINST DRUG ABUSE OBSERVED AT STATE CENTRAL PRISON, RONGYEK

Under the NALSA (Legal Services to the Victims of Drug Abuse and Eradication of Drug Menace) Scheme, 2015, an interactive programme on the theme 'Listen First' was organized in the State Central Prison, Rongyek, East Sikkim on 26<sup>th</sup> June, 2017.

The programme was organized by Sikkim State Legal Services Authority under the guidance of Hon'ble Executive Chairperson and in collaboration with NGOs viz; Serenity

Home, Jagriti (ASHI) and Sikkim Rehabilitation and Detoxification Society (SRDC).

The programme was attended by Mrs. Matilda Isaacs, Special Secretary, Sikkim SLSA, Mr. K.B. Gurung, Senior Superintendent of Police (State Jail), Chief Medical Officers of Central Referral Hospital, Manipal viz; Dr. Satyadeep Chettri and Dr. Samrat Bhandari, Mr. Jiwan Rai, Research Officer, Mr. Dewaker Basnett of 24 Hours Inspired, recovering addicts and alcoholics, staff and personnel along with the inmates of State Central Prison, Rongyek.



As per the resolution passed during the meeting chaired by Hon'ble Executive Chairperson on 19<sup>th</sup> September, 2016, an in-depth counseling by psychiatrists and experts from the NGOs are provided to the recovering addicts on a regular basis. 35 inmates at State Central Prison, Rongyek were provided counseling in the first batch which was undertaken by Sikkim Rehabilitation and Detoxification Society, Nimtar and 62 inmates have benefitted in the last three months through Jagriti Integrated Rehabilitation Centre for Addict, Sichey and Serenity Home, Lower Burtuk.
