

#### LEGAL AID STALLS SET UP DURING MAGHEY MELA

The programme was attended by Mr. Jagat Rai, District & Sessions Judge, North at Mangan and Chairman, District Legal Services Authority (North), Shri Benoy Sharma, Civil Judge-cum-Judicial Magistrate, North at Mangan and Secretary, District Legal Services Authority (North) along with Panchayats, students of Mangshila Senior Secondary School and the local public.

The participants were apprised about how various disputes including matrimonial and family could be settled through mediation. They were explained about the procedure and role of a mediator.

High Court Lok Adalat was also held on 22.03.2016 in the office of Sikkim State Legal Services Authority, Development Area, Gangtok, East Sikkim which was presided by Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim/Executive Chairperson, Sikkim SLSA along with Shri G.P. Pradhan and Shri D.K. Gazmer as the "Other Person". 03 cases were taken up.

National Lok Adalat was held on 13.02.2016 relating to bank matters. 213 cases were taken up wherein 104 cases were successfully settled. Total amount awarded was ₹89,95,771/-
