UNDERTRIAL REVIEW COMMITTEE SPECIAL CAMPAIGN

Hon'ble Mr. Justice Sanjay Kishan Kaul, Judge, Supreme Court of India & Executive Chairman, National Legal Services Authority (NALSA), launched a nationwide campaign from 18th September to 20th November, 2023 to expedite the identification of prisoners who are eligible to be considered for release and follow- up on their applications for release.

The Campaign aimed to bolster and accelerate the functioning of the existing Undertrial Review Committees (UTRCs), which are district- level bodies headed by the respective Ld. Principal District & Sessions Judges. The Undertrial Review Committees also consist of the District Magistrates; Superintendents of Police; Secretaries of the District Legal Services Authorities; and Officers-in-Charge of Prisons, as its members.



The virtual launch event was attended by the Executive Chairpersons and Member Secretaries and other functionaries of all the State Legal Services Authorities, Secretaries of the DLSAs and other members of the UTRCs.

Hon' ble Mr. Justice Sanjay Kishan Kaul further reminded everyone that "Our responsibility as judges is to ensure that the law is followed in letter and spirit, and that it does not discriminate between anyone on the basis of the quality of legal representation they can afford among other man-made qualifiers". In his address, Justice Kaul explained the intrinsic linkages between a robust legal aid system, access to justice and the attainment of the Sustainable Development Goals, an aspect that has been in focus during the G20 Summit- 2023 and which was also one of the resolutions adopted in the G-20 New Delhi Leaders' Declaration.

UNDERTRIAL REVIEW COMMITTEE SPECIAL CAMPAIGN

Ms. Santosh Snehi Mann, Ld. Member Secretary, National Legal Services Authority, in her address, also harped on the mandate of UTRC to prevent imprisonment of undertrials, solely on account of financial constraints or lack of legal representation. She urged the UTRCs to ensure that the wheels of justice gain momentum, ensuring that no individual is left stranded in the intricate web of legal proceedings for want of proper and timely legal representation and regardless of their circumstances. She reiterated the principle that *'Bail is the rule & jail is the exception.'* She exhorted the members of the UTRCs to rise to this clarion call and identify as many UTPs as they could for moving applications for release during pendency of trial.

MEGA LEGAL AWARENESS CAMP

On 28.09.2023, DLSA, Leh under the aegis of NALSA & Ladakh Legal Services Authority, organized a Mega Legal Awareness Camp at Central Institute of Buddhist Studies, Choglamsar, Leh. Hon'ble Mr. Justice Sanjay Kishan Kaul, Judge, Supreme Court of India and Executive Chairman, NALSA was the Chief Guest on the programme, which was also graced by Hon'ble Mr. Justice N. Kotiswar Singh, Chief Justice, High Court of J & K and Ladakh & Patron-in-Chief, Ladakh Legal Services Authority; Hon'ble Mr. Justice Atul Sreedharan, Judge, High Court of J & K and Ladakh & Executive Chairman, Ladakh Legal Services Authority and Dr. Pawan Kotwal, Advisor to Hon'ble Lt. Governor of Ladakh. In his inaugural address Hon'ble Justice S. K. Kaul stated that legal awareness means the ability to understand words used in a legal context, to draw conclusions from them, and then to use to those conclusions to take action. His Lordship emphasized that the various organs/agencies should strive to achieve the constitutional objective of access to justice to all, particularly the marginalized and vulnerable sections of the society.

COLLOQUIUM ON PROTECTING CHILD RIGHTS

On 17.09.2023, a State-level Colloquium on “Protecting Child Rights: Legal Perspective and Training”, was organized by Jharkhand State Legal Services Authority, in association with the Department of Women, Child Development and Social Security, Govt of Jharkhand; Kailash Satyarthi Children’s Foundation and Bachpan Bachao Andolan, at Dr. A.P.J. Abdul Kalam Auditorium at Jharkhand Judicial Academy. The programme was graced by Hon’ble Mr. Justice Sanjay Kishan Kaul, Judge, Supreme Court of India & Executive Chairman, NALSA, who was the Chief Guest of the event; Hon’ble Mr. Justice Sanjaya Kumar Mishra, Chief Justice, High Court of Jharkhand cum Patron-in-Chief, JHALSA; Hon’ble Mr. Justice S. Chandrashekar, Judge, High Court of Jharkhand & Executive Chairman, JHALSA; Hon’ble Mr. Justice Sujit Narayan Prasad; Hon’ble Mr. Justice Rongon Mukhopadhyay and other Hon’ble Judges of High Court of Jharkhand.

Hon’ble Mr. Justice Rongon Mukhopadhyay, Judge, Jharkhand High Court gave the welcome address wherein he thanked the judicial officers, police officials, members of Civil Society organizations etc. for gracing the occasion.

This was followed by the Opening Address by Hon’ble Mr. Justice Sujit Narayan Prasad, wherein he stated that ‘Children constitute the nation’s valuable human resources. The future wellbeing of the nation depends on how its children grow and develop’. He also quoted the great bard Milton, who had beautifully stated that ‘A child shows the man as morning shows the day’. He stated that it was the bounden obligation of the society to look after every child with a view to ensure the full development of his personality as children were the future custodians and torch bearers of the society being the messengers of our knowledge, cultural heritage, ideologies and philosophies.

The Introductory Address was delivered by Hon’ble Mr. Justice Sanjaya Kumar Mishra, Chief Justice, High Court of Jharkhand. He stated that world over, the children are voiceless victims of physical, emotional and sexual violence, and India was not an exception. Delving upon existing legal framework in India, he added that the enactment of POCSO Act in 2012 and J.J. Act in 2015 were watershed moments in the history of Child Rights in India as these Acts look after and zealously safeguard the best interests of a child. Justice Mishra also pointed out two harmful stereotypes regarding sexual abuse. Firstly, that only girls can be subjected to sexual or physical abuse, and not boys; and secondly, that the offenders are generally persons not known to the child. He exhorted the audience to debunk these myths and stereotypes. He expressed a sincere hope that concerted efforts of all stakeholders shall curb the menace of child sexual abuse, by not only protecting innocent children from sexual abuse but also by restoring lost childhoods by meeting the rehabilitative needs of child victims.

COLLOQUIUM ON PROTECTING CHILD RIGHTS

Hon'ble Mr. Justice Sanjay Kishan Kaul, addressed the august gathering wherein he said that 'Children are the future of the nation and their rights must be safeguarded to install them to their fullest vigour. Unfortunately, however India and many other countries face some challenges in this regard and there is an urgent need to address these challenges head-on and act collectively to protect and uphold their rights'.

Justice Kaul also emphasized that 'Every child regardless of gender, caste, social structure they belong to, deserves to be treated with dignity, respect and equality.' He referred to International Conventions and instruments as well as domestic legislations, safeguarding rights of children, while exhorting the concerned stakeholders including the Legal Services Institutions, to do their bit for effective realisation of the rights of the children. Justice Kaul quoted Justice K. Ramaswamy's observations that children's earliest experiences significantly influenced their education and hence, the focus should be their immediate growth and their holistic development.

Justice Kaul further stressed that 'one of the pressing issues is of child labour. According to data available, millions of children are still employed in hazardous and exploitative labour across India. These children are denied the opportunity to seek education, jeopardizing their future prospects and perpetuating the cycle of poverty. Child labour is deeply intertwined with poverty, therefore addressing the issue of poverty is equally important. This required comprehensive social welfare programs, access to education, skill development, livelihood opportunity for parents of child labour, and empowering families to break the inter-generational cycle of poverty.



Hon'ble Mr. Justice S. Chandrashekhara Judge, High Court of Jharkhand proposed the Vote of Thanks to all the participants, delegates, resource persons, dignitaries and volunteers.

The Inaugural Ceremony was followed by four technical sessions on various topics such as:

- i. Schemes and Programmes for development and welfare of vulnerable children in Jharkhand;
- ii. The Legal Perspective;
- iii. Understanding Children and their vulnerability to abuse and exploitation; and
- iv. Preparation of Plan of Action (including timeline for sensitization of all the VLCPC members across the state).

At Community Level: Empowering Communities through Knowledge

Awareness Programs conducted by NALSA serve as powerful tools, bringing law closer to the common people, thereby empowering people and communities with knowledge and understanding of their rights, entitlements, and legal remedies. These Awareness Programs act as the much-needed bridge between citizens and the legal system, helping the 'aam aadmi' navigate the legal landscape, without feeling overwhelmed or intimidated by legalese. Here are a few vignettes of these sessions from across the expanse of the country.

- On 13.07.2023 and 16.07.2023, DLSA, Sonitpur, Assam, organized awareness programs on the topic: 'Evils of Child Marriage', at Panchmeel Gaon Panchayat and Bindukuri Gaon Panchayat respectively, where around 150 participants were informed about the ill effects of child marriage and the preventive/ punitive provisions regarding the same.

- On 15.07.2023, Meghalaya State Legal Services Authority, organised a Mega Camp-cum-Awareness Programme on the theme "Bridging the Gap", where people were informed about "NALSA and Government- Welfare Schemes". The Camp was organised at St. Francis De Sales Secondary School, Somonpara under Gambegre, Community and Rural Development Block, West Garo Hills district. To celebrate 25 years of legal aid services in Meghalaya, a project funded by the Department of Justice, titled "Increasing Access to Justice through Community Mediation" was also launched, whereunder the headmen or village court under District Council or Nokmas will be given special Mediation Training and would also be made to understand formal laws.

- From 24.07.2023 till 19.08.2023, DLSA, East District, Delhi, ran a program titled "Project Shat Pratishat Kanooni Saksharta" to create legal awareness amongst the residents of Ghazipur Village, East Delhi. Principal District and Sessions Judge, East District, Karkardooma Courts on 24.07.2023 from Karkardooma Court Complex and the culmination ceremony for the same was held at MCD Community Hall, Ghazipur Village on 19.08.2023. The culmination ceremony was graced by Hon' ble Mr. Justice Siddharth Mridul, Judge, High Court of Delhi and Executive Chairman, DSLSA.

At Community Level: Empowering Communities through Knowledge

- After the floods in Delhi in July, 2023, DLSA, Central District, Delhi, undertook relief work at relief camps at Pradhan Enclave and Parshuram Enclave, Burari, Mori Gate, Geeta Colony, Darya Ganj, Bela Estate etc. on 01.08.2023 and 02.08.2023 and facilitated in distribution of relief material, sanitary pads etc. The inhabitants of the said relief camps were also informed about the “NALSA Scheme for Legal Services to Disaster Relief Victims through Legal Services Authority”. Around 862 flood victims benefited out of the work done by DLSA, Central Delhi.



At Jails: Rekindling Hope behind Bars

- **Around 1,18,251** persons visited the **1200** Legal Services Clinics set up in different Jails across the country.
- Out of these persons, **82,418** received free legal advise and assistance.
- Around **91,070** prisoners availed the benefit of legal aid services (**47,177** individuals received advice and counseling; **39,500** were provided with Legal Aid Counsels to represent them in legal proceedings and **4,393** received other forms of legal aid and assistance).

- On 26.07.2023, DLSA, West District, Delhi organized an Awareness Program for inmates of Central Jail No. 5, Tihar Jail, Delhi, wherein they were informed about the provision of compounding of offences and early adjudication of cases by means of Plea Bargaining. A Legal Aid Counsel was the Resource Person for the said session, which was attended by 70 inmates.

STORIES OF IMPACT

SUCCESS STORY NO. 1: “Be the light at the end of the tunnel”

- A story was reported in the newspapers in Punjab regarding an Uzbek woman being arrested after being found loitering near the Indo-Pak border without her travel papers. Secretary, DLSA, Ferozpur, Punjab immediately took steps to interact with the said lady, who informed the Secretary, DLSA, that she had lost her papers and hence, couldn't go back to Uzbekistan. Taking note of the plight of the said lady, Secretary, DLSA, Ferozpur, got in touch with the authorities at Embassy of Uzbekistan to explore possibilities of repatriation of the said woman, thus rekindling a dim hope in the Uzbek women of being finally reunited with her loved ones back home.

SUCCESS STORY NO. 2: “Marriage can wait, Education cannot”

- On receiving information from a staff of an NGO ‘Shakti Vahini’ on 12.07.2023, regarding a marriage of a minor girl, which was about to be solemnized later in the day, without losing precious time, the Secretary, DLSA, Uttar Dinajpur, West Bengal alongwith one PLV and one staff, went to the house of the said girl child and counselled the child's mother regarding the harmful effects of child marriage and the penal consequences of such a marriage. The Secretary, DLSA, also explained to the mother of the girl that childhood needs to be lived and enjoyed and not be smothered and pushed down the precipice of an early marriage. Convinced, the mother of the minor girl gave an undertaking that she wouldn't marry off her daughter till the time she attained the legally permissible age for marriage and would also let her continue with her education.

SUCCESS STORY NO. 3: “Our mission: Compassion”

- With the intervention and counselling of a Para Legal Volunteer and a Legal Aid Counsel, from DLSA, South Chandrapur, Tripura, the long simmering disputes between Smt. ‘DD’ (a widow) and her in-laws were amicably resolved and the in-laws of the lady agreed to give a No Objection Certificate, which enabled the widow to get a job on compassionate grounds in place of her deceased husband. As they say, ‘All's well that ends well’. Both parties now live happy lives.

STORIES OF IMPACT

SUCCESS STORY NO. 4: “Visibilizing those who were hitherto Invisible”

- DLSA, Lakhimpur, Assam in collaboration with the District Administration, identified 3 transgenders and helped them get unique Identity Cards, thereby conferring on them a very important document, which would help them avail different kinds of benefits under different Government Schemes and policies and enjoying full personhood.

SUCCESS STORY NO. 5: “Making Rights a Reality”

- Coming to the aid of a widow, aged 62 years, Secretary, DLSA, Nabarangpur, Odisha, in coordination with the District Administration, got the Ration Card and Old Age Pension Card, issued in her favour. Further, since the widow was facing difficulty in walking on account of her advanced age, the pension and ration was directed to be delivered at her door- step. DLSA and the District Administration thus, lived upto their commitment of ‘Justice at the doorstep’.

SUCCESS STORY NO. 6: “Financial Security for those Grieving”

- Life had come to a standstill for Shri ‘SY’, when his father had an untimely demise on account of a road traffic accident. When Shri ‘SY’ shared his ordeal with a PLV working under DLSA, South East, Delhi, the latter informed Shri ‘SY’ about the provisions of the Delhi Victims’ Compensation Scheme- 2018. Once the untraced report was filed by the IO, Shri ‘SY’ was advised to file an application for compensation under the Delhi Victims’ Compensation Scheme- 2018. With assistance of a Legal Aid Counsel, Shri ‘SY’ moved an application before the concerned DLSA, and Rs. 10, 00, 000/- was awarded to the dependents of the deceased victim as final compensation, thereby providing some succor to the bereaved family.

SUCCESS STORY NO. 7: “Bridging familial chasms”

- Secretary, DLSA, Nellore, Andhra Pradesh, had received a petition from a young couple, whose respective families were opposed to their relationship and kept harassing them. Coming to the rescue of the young couple, Secretary, DLSA, Nellore held individual and group counselling sessions with the couple and their families. These efforts led to an amicable settlement of disputes between the couple and their families and both sides agreed to withdraw the several cases that they had filed against each other. With a single stone (settlement efforts), the Secretary, DLSA, Nellore, killed two bickering birds (or we may say, families).
