MEETING ON NALSA (LEGAL SERVICES TO THE VICTIMS OF DRUG ABUSE AND ERADICATION OF DRUG MENACE) SCHEME, 2015,

In terms of the resolution passed in a meeting held on 19th September, 2016, a meeting was held with the Director General of Police, Principal Secretary, Finance Revenue & Expenditure Department, Director General-cum-Secretary, Department of Health and Prison Authorities on 15.11.2016 in the Conference Hall of Sikkim SLSA. The meeting was chaired by Hon'ble Mrs. Justice Meenakshi Madan Rai, Judge, High Court of Sikkim and Executive Chairperson, Sikkim SLSA.

Modalities were worked out for rehabilitation and social reintegration of chemically dependent under-trial prisoners arrested for consumption of drugs and narcotics under SADA, 2006 and NDPS Act, 1985. Hon'ble Executive Chairperson informed that victims of drug abuse are being

de-criminalized in the rest of the world but certain provisions of SADA, 2006 is seen as impediment for rehabilitation of such persons. In terms of Section 3 of SADA, 2006 it is high time for identification, treatment, education, after case, rehabilitation and social reintegration of such persons.

It was finally resolved that Sikkim SLSA in co-ordination with the concerned Departments and Rehabilitation Centres would take a lead to counsel and rehabilitate under trial prisoners in all the jails of the State.
